You will be required to attend the Board meeting on designated date for a discussion, interview with the MDRC Board of Directors and a safety orientation on the club's various ranges, rules of conduct and the club facilities. You will be contacted by the Secretary within one week of completing your safety orientation regarding your membership approval and further arrangements to pay your dues and initiation fee, obtain your membership card and range keys. ALL INFORMATION REQUESTED IN THIS APPLICATION IS MANDATORY FOR MEMBERSHIP CONSIDERATION.
